

## **MEASURES TAKEN TO ENCOURAGE SHAREHOLDERS PARTICIPATION AT GENERAL MEETING**

### **(i) Dialogue between the Companies and Investors**

Any item of special business included in the notice of the meeting will be accompanied by a full explanation of the effect of the proposed resolution which is then separately voted on.
